THE BUDGET

As I mentioned above, this month saw us deliver a true Labour budget: one that will deliver relief to households across Peckham struggling with the pressure of the cost of living.

After 14 years of Tory austerity, child poverty had grown to unacceptable levels, with 4.5 million living in poverty. This is shameful. By scrapping the two-child limit this Government has taken bold steps to reverse this, and this one measure will lift more than half a million children out of poverty. I am so pleased that this will directly impact over 3,300 children living in Peckham. Giving those children the opportunity for a better future that they deserve.

We also announced measures to tackle the pressures of the cost of living. All of those on the National Living Wage will see their income go up, representing on average a £900 a year increase, putting more money directly in people's pockets. Freezes to crucial day-to-day expenditure such as rail fares, fuel duty and prescription charges will help tackle the costs people are facing. In particular, I know that the £150 cut to energy bills by this April will be warmly welcomed by households across Peckham, this is on top of the £150 discount to energy bills announced earlier this year for 6 million households.

VISIT TO MICHAEL FARADAY SCHOOL

Primary School this month to catch up with the Year 6s - this time on their own playground. We held a Christmas card competition, and they produced brilliant designs. Choosing just six to print and share with the community was no easy task! They're such bright, confident young people, and it's always a real pleasure to visit their school.

VISIT TO ARK WALWORTH

This month I was pleased to join members of Southwark Council and headteachers at the Ark Walworth Academy to discuss community policing and what we can do to support schools in our area. This was an important and positive discussion, and I will continue work with to stakeholders to ensure that children can feel safe and secure in their school.

MEETING WITH TRA CHAIRS FROM THE AYLESBURY ESTATE

I met with the Chairs of the Tenants and Residents' Associations (TRA) from the Aylesbury Estate to continue our ongoing discussions about upkeep and safety on the estate. We remain committed to working together through community town meetings, regular engagement with council officials, and ensuring residents' priorities are clearly heard and acted upon.

We have already seen important progress with the introduction of the Aylesbury Taskforce, and we will continue to work closely with the TRAs to make sure residents see the meaningful action they have been calling for.

CASEWORK UPDATE

This month, my casework team continued their dedicated work for residents, delivering two in-person constituency surgeries and responding to the many casework enquiries we receive each week. Their support helps ensure residents get the guidance and advocacy they need.

Here are some of the wins that we have secured for people.



SUPPORT SECURED FOR RESIDENT IN COUNCIL TAX DIFFICULTY

A local resident got in touch after falling into council tax debt while she was in hospital. Despite her situation, the council had sent bailiffs to her door. I intervened to get the bailiff action stopped immediately and to make sure the council's support team reached out to her to check what financial help she might be entitled to.

TRAVEL DOCUMENT DELAY SUCCESSFULLY CHALLENGED

I recently supported a constituent who had been unable to get hold of their refugee travel documents despite repeated attempts to contact the Home Office. After raising the case directly with the department, their documents were finally issued.

SAFFER STREETS ACHIEVED THROUGH COLLECTIVE ACTION

I've been working with the police, Hyde Housing, local councillors and residents to tackle a serious hotspot for antisocial behaviour in our community. Thanks to everyone's persistence, the property at the root of the behaviour has now been shut down.

POLICY UPDATE

This month, we responded to **314 emails** from constituents across a range of topics. I am grateful to all of you for taking the time write to me, and I ensure that we always try to respond to every email we receive. They are an important way of me understanding what people in the constituency think about what the government is doing, and this feedback shapes my work and priorities representing you in Parliament. Here are some of the issues that you raised with me this month.

RSPCA FIREWORKS CAMPAIGN

Several constituents contacted me regarding the impacts of fireworks on animals and people during the November firework season. A campaign led by the RSPCA highlighted how distressing this time can be. We are working on broader animal welfare reforms that prioritise safety. Additionally, we are advocating for 'firework-free zones', especially in neighbourhoods with a high density of families, pets, and individual's sensitive to noise.

THE FUTURE OF THE NHS

I am often contacted about the NHS, and the need for this government to continue to take action to protect and improve NHS services. Since coming into power, this government has made very significant investment in the NHS, and we also have a clear plan for reform and the roll out of community-based NHS services. I was pleased to see that during the budget this month the Chancellor took further spending action to cut NHS waiting lists with funding for 5.2m more appointments and 250 new Neighbourhood Health Centres.

CHILD POVERTY

my election, I have consistently received correspondence about the concerning number of children living in poverty. As I set out above, this Government's decision to scrap the two-child benefit cap was the single most effective way in which we could raise children out of poverty. But we are doing much more than that, by rolling out school breakfast clubs, free school meals, expanding childcare entitlements, and subsidising uniform costs, we are going even further to support families and children, to ensure that every child has the best start in life, no matter their personal circumstances.

LOOKING AHEAD

It is hard to believe it is so close to the end of 2025, it's been an incredibly busy year. But it is not over yet and before the year is out, I have much more to do!

This month, I am looking forward to launching a campaign with our local youth organisations to push for more support for youth provision in Peckham. Youth clubs and services provide communities for our young people where they don't just belong, but thrive.
